Pets are allowed to play with numerous toys during their stay. All toys are considered safe, but NOT indestructible. Occasionally, pets will ingest bits and pieces of toys. Usually, this is not a problem and will pass in time. Pets are carefully monitored to insure hazardous materials are not accessible. Your pet's safety is our utmost concern.

All pets must be on one of the topical flea preventatives listed below. If fleas or ticks are observed on your pet, we will administer a 24-hour flea treatment for a fee.
